# Reverendly Speaking

For we are what he has made us, created in Christ Jesus for good works, which God prepared beforehand to be our way of life.

Ephesians 2:10

### Dear People of St. Andrew's,

Dr. Robert Schuller—famous for coining the phrase *possibility thinking*—was once asked in an interview how he developed such a positive, optimistic outlook on life. He said he developed this attitude through his morning prayer time. Every morning, he would pray, "Dear Lord, lead me to the person You want to speak to through my life today. Amen."

That's an interesting prayer. "Dear Lord, lead me to the person You want to speak to through my life today." How could such a simple prayer change his whole outlook on life? Dr. Schuller says that this prayer caused him to see the people around him as opportunities for God's blessings. Because of this prayer, every interaction became an opportunity for God to speak through him. Don't misunderstand. He didn't assume he had all the answers. But the burden wasn't on him. He assumed that if he would do his part, God would work through him to bring some truth or love or mercy into that person's life.

What would change about your life if you viewed every moment as a limitless opportunity to live for God? Every moment. The time you spend commuting each morning. The conversations in the locker room or the conference room or the music room or on social media. What would those moments look like if you knew God was working through you to change people's lives?

In Ephesians 2:10, Paul writes, "For we are God's workmanship, created in Christ Jesus to do good works which were prepared in advance for us to do." Prepared in advance. God not only created us for good works, God prepared those good works for us in advance. God didn't just make you for a purpose, God made you with a plan in mind. God made you for specific good works that were prepared *in advance* for you to do. There is nothing random or meaningless about your life. Every moment was created for God's sacred purposes.

Doing great things for God begins with simple trust that the One who has called us will not forsake us as we seek to follow His call.

I was struck by some wise words written by finance blogger Bob Lotich comparing God with former Buccaneers quarterback Tom Brady. And no, he didn't say Brady can walk on water, though I'm sure some of his fans think he can. Here's what Lotich wrote: "God loves throwing lead passes."

What does that mean? "God loves throwing lead passes."

Lotich explains that a lead pass in football is when the quarterback throws a long pass not to where a receiver is, but to where a receiver is going. For a lead pass to work, the receiver runs ahead of the ball being thrown and trusts that the quarterback is going to throw it to just the right spot.

Bob writes, "With God, when you follow His principles, the results are almost always delayed. As in, when He asks you and me to do something, we rarely see the results of it immediately. We have to keep doing what we know He told us to do (running) and trusting that God will get us the results (the ball) somewhere downfield . . . If I were playing catch with NFL quarterback Tom Brady and he said, 'Just start running and the ball will be there when you get there,' I would trust him. He has 7 Super Bowl rings that prove he can sufficiently get the ball to a receiver downfield.

"How much more can we trust God when He says, 'Just start running. I'll take care of the rest'?

"Whatever you are trusting Him for today," says Bob Lotich, "just keep running, and trust that He's got it all worked out."

God's plan is not about you. It's not about me. It's about God working through us. But God gives us a choice. What we give to God, He will use for His purposes. So, what would happen if you gave everything to Him?

God made you for a sacred purpose. You can't un-hear that truth. Every moment you are alive is a sacred opportunity to do good works that God prepared in advance for you to do. The only obstacle standing between you and God's sacred purpose is your willingness. Will you give *every* part of your life to God? Will you refuse to let fear shrink your vision? If so, God can use you to bring hope and salvation to people who might never meet Him any other way. Decide today to trust everything to God's purposes, and God will use you to make an eternal impact in others' lives.

### Stations of the Cross: Fridays in Lent 12:10pm

Come and join us for this 30-minute devotional, observed on Fridays in Lent at 12:10pm running through Good Friday on April 15. Our Stations of the Cross, a gift from Nathan & Jane Simpson, are a series of pictures representing certain scenes in the <u>Passion of Christ</u>, each corresponding to a particular incident. Formerly the number of stations varied considerably in different places but fourteen are now generally acknowledged. The object of the Stations is to help the faithful to make in spirit, as it were, a pilgrimage to the chief scenes of Christ's sufferings and death. It is carried out by passing from Station to Station, with certain prayers at each and devout meditation on the various incidents in turn. It is very usual, when the devotion is performed publicly, to sing a stanza of the "Stabat Mater" while passing from one Station to the next.

#### Sunday mornings at 9:30

#### The One: Reaching the Lost with the Love of Christ – A Bible Study from Luke 15

Think about the happy relief that floods through you when you find a lost cell phone or a misplaced set of keys. This is just the tiniest hint of what it feels like to reach out to the ones in our lives who are spiritually lost...who have not yet discovered the rich love God has for them. Plus, as the parables in Luke 15 show us, to save "the one" is a wonderful way to respond to God's great love. Jesus tells stories about rejoicing when lost things are found–specifically, a lost sheep, a lost coin, and a lost child. *The One* uses these parables to teach us how to become passionate about sharing the love and message of Jesus to reach those who don't know God. We will discover that we are "the One" who is dearly loved and sought after by God.

## **Tuesday Evening Lenten Series**

Our annual Lenten Series will begin this year on Shrove Tuesday, March 2<sup>nd</sup>, and continues weekly through April 5<sup>th</sup> (with the exception of March 22<sup>nd</sup>, when St. Andrew's will host a portion of the Bach Bash).

Throughout Derrick's professional career, he has served in many supervisory and administrative capacities as a coordinator, manager, officer, director and administrator at Florida Memo-

rial College and Hillsborough Community College, respectively. In his various roles he took a keen interest in serving low-income, disadvantaged first-generation college students by motivating, mentoring, and helping them to persist academically and to graduate to the next level of higher education. In many instances, several of these students have joined the job market and are now productive citizens.

Over the years, he has had tremendous success in administering a multimillion dollar federal grant at HCC. For his diligent work he has received numerous awards and recognitions from the US Department of Education, professional educational associations, and HCC.

Derrick and his wife Beverley have two adult sons, Donreece and Warren. Since 1995, St. Andrew's has been the spiritual home for his family. Parishioners elected him twice in prior years to serve on the vestry and vestry committees. Beverley and Donreece have also served on the vestry at St. Andrew's. Derrick, Beverley and Donreece are lay eucharistic ministers while he and his two sons serve as ushers on different Sundays.

Attending church services on a regular basis is paramount for Derrick and his family. # IMPORTANT ANNOUNCEMENT REGARDING 2022 ANNUAL PARISH MEETING AND VESTRY ELECTIONS

Each year St. Andrew's conducts an annual parish meeting at the end of January or beginning of February, which includes vestry elections. Your current vestry has been anticipating the 2022 parish meeting and established procedures to allow voting either by mail or in person.

The 2022 Annual Parish Meeting will occur on **Sunday, February 6, 2022 following the 10:30 AM service.** The parish meeting **will be conducted in person** *and also* **will be virtual**. The vote for vestry elections will be conducted both in person and via US mail. The vestry voted unanimously to establish permanent procedures allowing parishioners to vote either by mail or in person going forward at all annual meetings.

As everyone is aware, the COVID-19 pandemic has changed many, many aspects of our lives. We are hopeful about the promise of the vaccines on the horizon. However, the risks presented by the pandemic are still very real and very present. The vestry determined it simply makes sense and serves the best interest of the parish to allow voting by mail or in person.

Since the vestry election will be conducted both through the mail and live, **no nominations for vestry** will be able to be made during the meeting. Therefore, we have established the following procedures:

- \*Vestry nominations will cut-off on Sunday, January 16, 2022. We welcome any eligible parish member wishing to run for vestry to nominate himself or herself. If someone does wish to run for vestry they must be nominated by the deadline on Sunday, January 16, 2022.
- \*Ballots then will be issued via US mail to all parishioners beginning on Tuesday, January 18, 2022.
- \*Ballots must be returned via US mail and <u>received in the parish office no later than close of business on Wednesday, February 2, 2022.</u>
- \*The ballots will be formatted and printed in such a manner as to allow parishioners to identify themselves on an outer envelope, and then to vote on a separate page. The certification and ballot then will be returned in a special envelope. Parish staff will open the envelopes, verify the eligibility of the voter, and then separate the ballots (which will remain unopened). The unopened ballots will be collected and presented to the tellers who will count them during the annual meeting election.
- \*Parish staff will create and circulate a list of who has submitted a ballot by mail. Those parishioners who have done so are not eligible to vote at the annual meeting.
- \* The new vestry members will be announced during the Annual Parish Meeting and immediately following the tally by the tellers.

The vestry unanimously and sincerely believes these new procedures will lead to greater participation for all parishioners. Of note, with the 2021 vestry elections by mail, we had the greatest participation in recent memory. # **December 2021 Vestry Meeting Highlights**

#### **RECTOR'S REPORT**

As of 12/6/21, there was \$158,529 in ops account and \$83,507 in the parish reserve account.

As of 12/7/21, there was \$24,382 in the Foundation's checking account – monies available to the vestry.

We have \$20,659 available from the Foundation principal as a result of the 4% spending allocation designated by the Foundation Board for 2018 at their meeting on 2/21/18. (On 1/27/21, \$20,000 of the \$75,659 allocated for 2018 was transferred from the principal to the checking account. On 7/21/21, another \$20,000 from the 2018 allocation was transferred from the principal to the checking account. On 10/5/21, another \$15,000 was transferred from the principal to the checking account.)

We have \$63,718 available from the Foundation principal as a result of the 3% spending allocation designated by the Foundation Board for 2019 at their meeting on 2/27/19.

We have \$72,918 available from the Foundation principal as a result of the 3% spending allocation designated by the Foundation Board for 2020 at their meeting on 2/4/20.

We have \$81,371 available from the Foundation principal as a result of the 3% spending allocation designated by the Foundation Board for 2021 at their meeting on 3/3/21.

Total available funds from principal for years 2018 thru 2021: \$238,667.

There was \$3,217,463 in the Foundation principal as of 11/3/21, as opposed to \$2,929,677 on 12/31/20 (an increase of \$287,786 for the year to date).

There is also approximately \$99,000 in the Dan Curtis fund fbo St. Andrew's within the Community Foundation of Tampa Bay. This fund is designated for church maintenance purposes. We spent the 2021 allocation of \$4,250 to pay TNT Roofing for repairs to the NW corner of church roof.

Confirmation - was on 11/21 at 10:30 service. Bishop Michael Garrison confirmed/received two youth and eight adults. Parish life hosted a fine reception afterward.

Pictorial Directory – Pam and Lauri in office are working on this, it will be an online directory that can be continuously updated and shared electronically with parishioners. Hope to have this published by February at the latest.

Newcomers' Dinner – Perhaps sometime early next year, depending on the Covid (hosted by the vestry at the rectory).

Columbarium Project – Benches (two for columbarium area and one for south garden next to church) are on order.

Annual Stewardship Campaign – launched on 10/14. Many thanks to Gary, Richard, Jennifer S., and Lynn for speaking at Sunday services. First mailer (with a letter from Gary) went out on 10/14. Second mailer (with a letter from Gray) was sent out on 11/10. Third mailer (with a letter from Richard)

was sent out on 12/9. As of 12/9, we have 111 pledges for 324K (compared to 110 pledges for 315K as of this time last year).

There are still 63 pledgers who pledged 143K in 2021 whom we have not heard from for 2022. With that in mind, you will receive names and phone numbers of such people at the vestry meeting on Monday. I will send sample copies of how to make your phone calls. *Please make every effort to attend Monday's meeting!* Another pledge mailing will go out in early January.

Vestry Nominations – we are seeking candidates to run, with the election to take place at the annual parish meeting (and via the USPS), which is 2/6/22 after the 10:30 service.

Christmas Eve services will be on Christmas Eve, 12/24 at 5:30PM and 11PM, with pre-service music beginning 30 minutes prior to each service. These services will, God willing, be broadcast live on St. Andrew's Facebook page and YouTube channel.

Christmas Day service will be on Christmas Day, 12/25 at 10AM.

Sunday services as usual on 12/26 (but choir will have off for 10:30 service that day)

Annual Meeting – Sunday, 2/6/22 after 10:30 service – includes vestry election

Father Reese reported that Jim Morgan is resigning from the Vestry due to health reasons. Because it is mid-term, the vestry has the authority to appoint a person to fill the un-expired term. Loueita Hargens was the runner-up in the last vestry election. She is willing to serve the unexpired term, which ends in February 2023. All were in agreement to appoint Loueita to fill the rest of Jim's term.

**SENIOR WARDEN'S REPORT:** Gray Sanders – The Columbarium is nearing completion. Gray let the Vestry know that Nancy will be approaching the Vestry to add another project to the Columbarium, a mosaic. Gray has a working list of Vestry candidates and is in conversation with them.

**JUNIOR WARDEN:** George Levy -The new leak in the lower roof has been addressed. Church leaks have been addressed. George is very pleased with the contributions and the quality of work that the Sexton, Anguel, is doing for the church.

**TREASURER: Richard Ferlita** – We received a good monthly check of \$5,000 from 717 Parking. He feels we will do well for Christmas Eve services. We should end the year in good shape.

**HOMELESS PROGRAM: Sue McIsaac** – Thanksgiving feeding partnered with Metropolitan Ministries went fairly smoothly, and finished quickly.

**OUTREACH:** Lori Taplow – Gabriel Tree – the gifts have been distributed to both schools. Over 100 children in 35 families were served. Some of the new families got involved in volunteering. More details will appear in the bulletin.

**PARISH LIFE: Pam Curry** – On Sunday they will host Lessons & Carols and the Parish Christmas Party. Pam asked for some additional dishes and wine which the Vestry committed to bringing.

**OLD BUSINESS:** Lori stated that Doug will rebuild the ramp for the boat in the children's play area, which needs to be replaced.

**NEW BUSINESS:** Father Reese and Paul Scheuer were asked to be excused. The Vestry discussed Christmas bonuses for all staff. The Vestry was in agreement for all.

Next vestry meeting will be on **Monday, January 24**<sup>th</sup> at **5:30p.m.** (not 1/17, which is Martin Luther King Day)


